# **BE AN INFORMED VOTER**

This Voter's Guide is produced by the League of Women Voters of Southwest Missouri to educate Greene, Christian, and Webster County citizens on the positions of candidates seeking office and to learn about proposed ballot issues.

The League contacted each candidate three times by either email or phone.. When a candidate did not respond, that is noted next to their name. Candidates are listed by political party in the order they appear on the ballot. This is determined by the party of the current governor, so for this election, Republicans are listed first.

> ALL INFORMATION FROM CANDIDATES IS PRINTED EXACTLY AS SUBMITTED and is not edited for spelling or grammatical errors.

#### **HOW TO VOTE: In-Person Voting on Election Day**

- Polls are open 6 a.m. to 7 p.m. on Election Day, Tuesday, Nov. 5.
- Important: If you are in line at 7 p.m. you have the right to cast your vote. You do not have to be finished voting by the time the polls close.
- The poll worker (election judge) will find your name on the list of registered voters, then ask you to show an approved ID (see gray box) and sign your name.
- Ask a poll worker if you are unsure how to mark your ballot or use the voting equipment.
- If you make a mistake on your ballot, you may request a new one from the poll worker.
- You **do not** have to vote on every candidate or issue for your ballot to be valid. You are allowed to leave some races/issues blank, as your votes on the other races/issues will still be counted.
- If you have questions, call the League's Vote411 Hotline, 866-687-8683 (VOTE) or the Missouri Secretary of State, 800-669-8683. Your County Clerk also can help; see County Clerk contact information on page 3.

#### DO I NEED IDENTIFICATION TO VOTE?

Show one of these forms of acceptable identification and sign the poll book to obtain your ballot:

- A Missouri driver or non-driver license; If your license expired after November 8, 2022, you are still eligible to vote
- A non-expired military ID, including a veteran's ID card
- A non-expired United States passport
- Another photo ID issued by the United States or the state of Missouri; If your photo ID expired after November 8, 2022, you are still eligible to vote

#### **PROVISIONAL BALLOTS**

If you do not have any of these forms of identification but are a registered voter, you may cast a provisional ballot. Your provisional ballot will count if:

- You return to your polling place on Election Day with a photo ID
- Your County Clerk determines your signature on the ballot envelope matches your signature on your voter registration record
- If you cast a provisional ballot, you'll receive instructions on how to verify that your ballot counted

#### IN-PERSON ABSENTEE VOTING vs MAIL-IN ABSENTEE VOTING

#### In-person absentee voting:

• In-person absentee voting begins September 24 and requires a reason for voting absentee and a current photo ID.

#### No-excuse in-person absentee voting:

- During the two weeks prior to the election, you may vote no-excuse in-person absentee and will need to show a current photo ID. A reason for voting absentee is not required.
- All in-person absentee voting takes place at your local election authority's office or other designated locations.

#### Mail-in Absentee Voting:

- Voters can request absentee ballots from their local election authority in person, by mail, by fax, or by email until 5pm on October 23.
- Relatives within the second degree (spouse, parents, and children) can request absentee ballots, in person, on behalf of a voter who wishes to vote absentee.
- For mail-in absentee ballots to be counted, they must be received in the election authority's office by 7:00 pm on Tuesday, November 5.

#### **ACCEPTABLE EXCUSES FOR VOTING ABSENTEE INCLUDE:**

- Absence from jurisdiction on Election Day
- Incapacity or confinement due to illness or physical disability on election day, including a caretaker who lives with you
- Religious belief or practice
- Employment as an election worker, first responder, health care worker or member of law enforcement
- Incarceration, provided you are still qualified to vote
- Certified participant in an address confidentiality program

#### Why are you qualified to serve in this office?

For the past three years, I have served as the Assessor, gaining valuable experience in the office. My background is in analytics, demographics, and geographic technologies. # What is the biggest challenge facing the office you are seeking?

One of the biggest challenges for this office is operating within the constraints of limited funding. The Assessor's Office does not receive funding from General Revenue but relies on the reimbursement and collection formula provided by the State of Missouri. As costs for software, data, and technology continue to rise, it becomes increasingly difficult to remain competitive in hiring and retaining staff.

# How can you increase the communication between this office and the community?

Over the past three years, I have focused on improving communication with the community. We introduced an e-appeal system, allowing residents to submit appeals online, provided an online tool to check the status of personal property assessments, and offered scheduled meetings with staff to discuss individual properties. I am also working on increasing transparency by listing all abated and exempt properties, so the community can see how much value is being reduced to zero.

I additionally have held some community workshops on the assessment process and other related items.

#### Why are you qualified to serve in this office?

#### Why are you qualified to serve in this office?

As a 20 year resident of Christian County, I have put down roots and raised my kids here. #### Why are you qualified to serve in this office?

I have lived in Christian County for over 50 years. This led me to begin working for Ken Davis, current Christian County Public Administrator in 2009. In my tenure, I have learned valuable information about the job duties of the Public Administrator. Learning how best to serve and meet the needs of the wards we were appointed to, which is one of the most important parts of the job. By doing so, I was able to advance my position to Chief Deputy Public Administrator in 2019. Since that time, I have made executive decisions for our wards in the same capacity that the Public Administrator would. I previously worked for retired Social Security Judge Martin Spiegel, who educated me on Social Security Disability, which is a huge part of what we deal with here at the office. We work daily with the Department of Social Security, Department of Family Services, and the Veterans Administration among others, it's challenging but also extremely rewarding.

#### What is the biggest challenge facing the office you are seeking?

The biggest challenge we face is being appointed, by our Probate Judge, to the Estate of an incapacitated individual, or a Personal Representative. Each estate is uniquely different with its own nuances. We have never had two that were the same and each comes with their own challenges to overcome. I think we have done a great job over the last 15 years and I hope to continue to do so in the future.

#### How can you increase the communication between this office and the community?

I plan to continue the same "open door" policy that we currently have established in our office. When someone has a question, or concern, regarding the areas of Guardianship, Conservatorship, and Probate matters that we are involved with daily, I will be readily available and willing to discuss those matters. I will do my very best to assist, or guide them, with any advice or information we may have. #### Why are you running for Senate?

Like so many voters, I'm exhausted and frustrated by the state of our national politics. The two major parties have decided that hatred, anger, and fear are their best tools for winning elections. I'm running to represent the reasonable majority of Missourians who are looking for leaders who know how to disagree productively and work together to solve complex problems.

What would be your top priority for Congressional action in 2025? Briefly discuss how you would address this priority.

My top priority would be working to get our nation's finances in order. Neither major party seems interested in talking about the issue, and yet our irresponsible spending has fueled inflation and put Social Security, Medicare, and our entire economy on dangerous ground. As an independent in a divided Senate, I will force discussions on this vital but neglected issue.

#### MISSOURI CONSTITUTIONAL AMENDMENT 2:

**Simple majority required** (one more than 1/2 of all of the votes)

Ballot wording: Do you want to amend the Missouri Constitution to: allow the Missouri Gaming Commission to regulate licensed sports wagering including online sports betting, gambling boats, professional sports betting districts and mobile licenses to sports betting operators; restrict sports betting to individuals physically located in the state and over the age of 21; allow license fees prescribed by the Commission and a 10% wagering tax on revenues received to be appropriated for education after expenses incurred by the Commission and required funding of the Compulsive Gambling Prevention Fund; and allow for the general assembly to enact laws consistent with this amendment? State governmental entities estimate onetime costs of \$660,000, ongoing annual costs of at least \$5.2 million, and initial license fee revenue of \$11.75 million. Because the proposal allows for deductions against sports gaming revenues, they estimate unknown tax revenue ranging from \$0 to \$28.9 million annually. Local governments estimate unknown revenue.

Summary: The amendment was put on the ballot through the initiative petition process and would add a section to Article III of the Missouri Constitution. If passed, it would allow the Missouri Gaming Commission to regulate licensed sports wagering including online sports betting, gambling boats, professional sports betting districts and mobile licenses to sports betting operators. Gambling would be limited to individuals over 21 and physically located in the state. It would allow license fees to be determined by the Commission and a 10% wagering tax on revenues received after expenses and required funding of the Compulsive Gambling Prevention fund were paid. Remaining revenue would be appropriated to education. State governmental entities estimate onetime costs of \$660,000 and ongoing annual costs of at least \$5.2 million. Because deductions are allowed, estimates of generated revenue range from \$0 to \$28.9 million annually. Local governments do not have estimates of annual revenue.

Proponents say that 38 other states have legalized sports betting and that unregulated gambling is widespread. Legislators say that sports betting could draw increased revenue for the state and particularly for educational programs to which portions of the revenue would be appropriated.

Opponents say Amendment 2 would increase compulsive gambling with its negative consequences and that the low tax rate will not generate enough revenue to justify the human costs. They also say the proposition lacks the mechanisms necessary for state agencies to collect and deposit revenue generated.

#### **MISSOURI CONSTITUTIONAL AMENDMENT 3:**

**Simple majority required** (one more than 1/2 of all of the votes)

Ballot wording: Do you want to amend the Missouri Constitution to: establish a right to make decisions about reproductive health care, including abortion and contraceptives, with any governmental interference of that right presumed invalid; remove Missouri's ban on abortion; allow regulation of reproductive health care to improve or maintain the health of the patient; require the government not to discriminate, in government programs, funding, and other activities, against persons providing or obtaining reproductive health care; and allow abortion to be restricted or banned after Fetal Viability except to protect the life or health of the woman? State governmental entities estimate no costs or savings, but unknown impact. Local governmental entities estimate costs of at least \$51,000 annually in reduced tax revenues. Opponents estimate a potentially significant loss to state revenue.

Summary: This amendment put on the ballot by initiative petition would establish a right to make decisions about reproductive health care, including but not limited to birth control, abortion care, prenatal care and childbirth, and miscarriage care. It would remove Missouri's abortion ban but would allow abortion to be regulated after fetal viability except to protect the life or health of the woman. The government would be prohibited from discriminating, in government programs, funding, and other activities, against people obtaining or providing reproductive health care services. The financial impact on state and local government revenue is unknown.

Proponents say decisions around pregnancy, abortion, contraceptives, and miscarriages are private and should be made by individuals, not the government. They also say Amendment 3 will preserve the health of individuals seeking necessary reproductive health care.

**Opponents** support the current strict ban on abortion.

#### STATE BALLOT MEASURES

#### **MISSOURI CONSTITUTIONAL AMENDMENT 5:**

**Simple majority required** (one more than 1/2 of all of the votes)

Ballot wording: Do you want to amend the Missouri Constitution to: allow the Missouri Gaming Commission to issue one additional gambling boat license to operate on the portion of the Osage River from the Missouri River to the Bagnell Dam; require the prescribed location shall include artificial spaces that contain water and are within 500 feet of the 100-year base flood elevation as established by the Federal Emergency Management Agency; and require all state revenues derived from the issuance of the gambling boat license shall be appropriated to early-childhood literacy programs in public institutions of elementary education? State governmental entities estimate one-time costs of \$763,000, ongoing costs of \$2.2 million annually, initial fee revenue of \$271,000, ongoing admission and other fee revenue of \$2.1 million annually, and annual gaming tax revenue of \$14.3 million. Local governments estimate unknown revenue...

Summary: This amendment, placed on the ballot through initiative petition, would allow the Missouri Gaming Commission to issue one additional gambling boat license to operate on the Osage River near the Bagnell Dam. If passed, the total number of gambling boat licenses would increase to 14. All revenues generated, after operating costs, would be appropriated to earlychildhood literacy programs in public elementary school institutions. State governmental entities estimate one-time costs of \$763,000, ongoing costs of \$2.2 million annually, initial fee revenue of \$271,000, ongoing admission and other fee revenue of \$2.1 million annually, and annual gaming tax revenue of \$14.3 million. Local governments estimate unknown revenue.

**Proponents** say that the additional gambling boat would generate funds for early-childhood literacy programs in public education that Missouri children need. They also say that the casino would generate jobs and aid the local economy.

Opponents say that the Osage Nation also had a proposal to operate a casino in the area, but was bypassed by the commercial entities behind Amendment 2. The tribe argues that the use of the name "Osage" in the amendment is deceptive, because it suggests that the Osage Nation is involved. The tribe has strong cultural and historic ties to the proposed casino location that have been taken away over time. An application from the tribe is pending before the Department of the Interior and the proposed casino could negatively affect the tribe's ability to pursue their project. They also say the revenues generated would not increase educational funding significantly.

#### **MISSOURI CONSTITUTIONAL AMENDMENT 6:**

**Simple majority required** (one more than 1/2 of all of the votes)

Ballot wording: Shall the Missouri Constitution be amended to provide that the administration of justice shall include the levying of costs and fees to support salaries and benefits for certain current and former law enforcement personnel? State and local governmental entities estimate an unknown fiscal impact.

Summary: This amendment, placed on the ballot by the Missouri Legislature, would amend Section 14 of the Missouri Constitution to include the levying of fees to support benefits and salaries of law enforcement staff including present and former sheriffs, present and former prosecuting attorneys, and current and former circuit attorneys. State and local governmental entities estimate an unknown fiscal impact.

Proponents say the revenue generated from court fees would fund robust pensions for sheriffs and law enforcement personnel.

**Opponents** say it would create a set of incentives that tie pensions to the volume of arrests and prosecutions. They also say that in 2020, the Missouri Supreme Court said a \$3 fee that was charged on every court case in Missouri to fund the sheriffs' retirement system was an unconstitutional "sale of justice."

#### **MISSOURI CONSTITUTIONAL AMENDMENT 7:**

**Simple majority required** (one more than 1/2 of all of the votes)

Ballot wording: Shall the Missouri Constitution be amended to: make the Constitution consistent with state law by only allowing citizens of the United States to vote; prohibit the ranking of candidates by limiting voters to a single vote per candidate or issue; and require the plurality winner of a political party primary to be the single candidate at a general election? State and local governmental entities estimate no costs or savings.

Summary: The measure, put on the ballot by the Missouri Legislature, would amend Sections 2 and 3 to state that only citizens aged 18 and over can vote in any Missouri state or local election. It would prohibit any alternative election system such as rank choice voting to be used in Missouri elections and require plurality primary elections where one winner advances to the general election. The one exception would be St. Louis City where approval voting is used.

Proponents say only U.S. citizens should vote in any election and local governments must be banned from allowing non-citizens to vote in local elections. They also say alternative election systems are too complicated and would jeopardize fair elections.

**Opponents** say that current law already prohibits non-citizens from voting and that this is "ballot candy" designed to confuse or mislead voters. They also say local governments and voters should decide which election system is best and this initiative takes away local election control.

#### **MISSOURI PROPOSITION A:**

Simple majority required (one more than 1/2 of all of the votes)

Ballot wording: Do you want to amend Missouri law to: increase minimum wage January 1, 2025 to \$13.75 per hour, increasing \$1.25 per hour each year until 2026, when the minimum wage would be \$15.00 per hour; adjust minimum wage based on changes in the Consumer Price Index each January beginning in 2027; require all employers to provide one hour of paid sick leave for every thirty hours worked; allow the Department of Labor and Industrial Relations to provide oversight and enforcement; and exempt governmental entities, political subdivisions, school districts and education institutions? State governmental entities estimate one-time costs ranging from \$0 to \$53,000, and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027. State and local government tax revenue could change by an unknown annual amount depending on business decisions.

Summary: This measure was put on the ballot by initiative petition and would amend Missouri law to increase the minimum wage to \$13.75 per hour on January 1, 2025 and to \$15.00 per hour in 2026. Each January beginning in 2027, the minimum wage would be adjusted according to the Consumer Price http://url.us.m.mimecastprotect.com/s/8Sm5C73ygLsVXOznmS8fyFoN2Xi?dom ain=index, in 2024, the Missouri minimum wage is \$12.30 per hour and all private businesses in Missouri must pay at least the minimum \$12.30 hourly rate. This minimum wage law does not apply to public employees. For tipped employees, employers must pay at least 50% of Missouri's minimum wage, or \$6.15 per hour in 2024. Employers must cover any tip shortages to ensure that an employee makes a total of \$12.30 per hour. Some exceptions to the minimum wage law include retail or service businesses with an annual gross income of less than \$500,000, certain full-time students who are working part-time, and most agricultural or farm employees. All employers would also be required to provide one hour of paid sick leave for every 30 hours worked. The Department of Labor and Industrial Relations is to provide oversight and enforcement. State governmental entities estimate onetime costs ranging from \$0 to \$53,000 and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027. State and local government tax revenue could change by an unknown annual amount depending on business decisions.

Proponents say workers need higher wages and paid sick days to support themselves and their families. In addition, they say the gradual increase over three years is feasible for employers. They also say hard work should be rewarded and not punished if workers need time off for illness or to take care of their families.

**Opponents** say businesses will have difficulty meeting these increases and will pass on the costs as increased prices.
